Should the customer indicate by endorsement in the space provided on the airbill that the receiver shall be liable for any customs duties, the customer shall be liable for any customs duties in the event of a default in payment by the receiver. 13. NON-DELIVERY OF SHIPMENT:  
Notwithstanding the shipper's instruction to the contrary, the shipper shall be liable for all costs and expenses related to the shipment of the cargo for costs incurred in either returning the shipment or warehousing the shipment pending disposition.

14. INSURANCE:  
a) ARAMEX maintains cargo liability insurance to the full extent of the liability offered to the shipper.

15. WARSAW CONVENTION:  
Where the rules relating to liability established by the Warsaw Convention or the Montreal Convention apply, carrier liability is governed by and shall be limited in accordance with such rules. Subject to applicable law, where the Warsaw Convention or the Montreal Convention do not apply, liability to loss or damage is governed by these terms and conditions and shall be limited to proven damages up to an amount not exceeding USD 100,000 per shipment.
