CONDITIONS OF CARRIAGE

1. INTENDING THE SHIPMENT FOR CARRIAGE, CUSTOMER AGREES TO THESE TERMS AND CONDITIONS OF CARRIAGE AND THAT HE IS NOT ABLE TO RETURN THE GOODS TO THE SHIPPER.

2. THESE CONDITIONS SHALL GOVERN AND APPLY TO ALL SERVICES PROVIDED BY ARAMEX. BY SIGNING THIS AIRBILL, THE CUSTOMER ACKNOWLEDGES THAT HE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX SHALL NOT BE BOUND BY ANY AGREEMENT WHICH VITIATES THESE CONDITIONS, WHETHER SUCH AGREEMENT IS WRITING AND SIGNED BY AN AUTHORIZED OFFICER OF ARAMEX OR OTHERWISE.

3. THESE CONDITIONS SHALL CONSTITUTE THE ENTIRE AGREEMENT BETWEEN ARAMEX AND EACH OF ITS CUSTOMERS. NO OTHER CONDITIONS, WHETHER WRITING OR OTHERWISE, SHALL BE BINDING ON EITHER PARTY UNLESS THEY ARE INCORPORATED INTO THESE CONDITIONS BY REFERENCE.

4. ARAMEX'S OBLIGATIONS: ARAMEX agrees, subject to receiving payment of applicable rates and charges in full, to transport the goods from the place of origin to the place of destination, in accordance with the instructions of the customer, and to deliver the goods to the consignee at the place of destination, in accordance with the instructions of the consignee.

5. SERVICE RESTRICTION: ARAMEX reserves the right to refuse any documents or parcels from any person or company at its own discretion. ARAMEX reserves the right to abandon carriage of any shipment at any time after acceptance when such shipment could possibly cause damage or delay to other shipments, equipment or personnel or when such carriage is prohibited by law or is in violation of any laws or regulations.

6. LIMITATION OF LIABILITY: ARAMEX shall be liable for the actual value of the goods shipped, up to a maximum of One Hundred Dollars (US\$100.00) per shipment, unless the customer has declared the goods for a higher value and paid the applicable charges therefor.

7. LOSS OR DAMAGE: ARAMEX shall be liable for loss or damage to the goods, whether or not caused by its negligence, and for consequential loss or damage, up to the actual value of the goods, up to a maximum of One Hundred Dollars (US\$100.00) per shipment, unless the customer has declared the goods for a higher value and paid the applicable charges therefor.

8. CARRIER'S LIABILITY: ARAMEX shall not be liable for loss or damage to the goods, whether or not caused by its negligence, and for consequential loss or damage, up to the actual value of the goods, up to a maximum of One Hundred Dollars (US\$100.00) per shipment, unless the customer has declared the goods for a higher value and paid the applicable charges therefor.

10. CHARGES: Any rates quoted by ARAMEX for carriage are inclusive of all charges, including but not limited to, fuel, handling, and other charges, unless otherwise specified.

11. PROPERTY: ARAMEX will carry documents or goods which are the property of the customer and the customer warrants that it is authorized to accept and is accepting these conditions only on behalf of itself and not on behalf of all other persons who are or may hereafter be interested in the goods.

12. CLAIMS: ANY CLAIMS AGAINST ARAMEX MUST BE SUBMITTED IN WRITING TO THE OFFICE OF ARAMEX NEAREST THE LOCATION WHERE THE SHIPMENT WAS ACCEPTED, WITHIN SIXTY (60) DAYS OF THE DATE OF ACCEPTANCE BY ARAMEX.

13. NON-DELIVERY OF SHIPMENT: Notwithstanding the shipment to the consignee, the shipper shall be liable for all costs and expenses related to the shipment off the carrier's liability, including but not limited to, the cost of re-shipment or warehousing the shipment pending disposition.

14. INSURANCE: ARAMEX maintains cargo liability insurance to the full extent of the liability offered to the shipper. The shipper may obtain additional insurance coverage on behalf of the shipper in an amount not exceeding ten thousand dollars (US\$10,000).

15. WARSAW CONVENTION: Where the rules relating to liability established by the Warsaw Convention or the Montreal Convention apply, liability is governed by and shall be limited in accordance with such rules. Subject to applicable law, where the Warsaw Convention or the Montreal Convention do not apply, liability is governed by these conditions and shall be limited to the amount set forth in these conditions.
