CONDITIONS OF CARRIAGE

In tendering the shipment for carriage, the customer agrees to these terms and conditions of carriage and that this air bill is negotiable and has been prepared by the customer or on the customer's behalf by ARAMEX used in this condition. ARAMEX includes Aramex Co. Ltd and all operating divisions and subsidiaries of Aramex Ltd and their respective agents, servants, officers and employees.

1. SCOPE OF CONDITIONS
These conditions shall govern and apply to all services provided by ARAMEX SIGNING THIS AIRBILL, THE CUSTOMER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX shall not be bound by any agreement which varies from these conditions such agreement is in writing and signed by an authorized officer of ARAMEX or the shipper or consignee. These conditions shall constitute the entire agreement between ARAMEX and each of its customers. Employee off: ARAMEX shall have the authority to alter or waive these terms and conditions as stated herein.

2. ARAMEX OBLIGATIONS
ARAMEX agrees, subject to receiving payment off applicable rates and charges in effect on the date off acceptance by ARAMEX off a shipment to arrange for the transportation off the shipment between the locations agreed upon by ARAMEX and the customer. ARAMEX reserves the right to transport the consignment by any route and procedure and by successive carriers and according to its own handling, storage and transportation methods.

3. SERVICE RESTRICTION
a) ARAMEX reserves the right to refuse any documents or parcels from any person or company at its own discretion.
b) ARAMEX reserves the right to abandon carriage off any shipment at any time after acceptance when such shipment could possibly cause damage or delay to other shipments, equipment or personnel or when any such carriage is prohibited by law or is in violation off any off the rules contained herein.
c) ARAMEX reserves the right to open and inspect any shipment consigned by a customer to ensure that it is capable off carriage to the state or country off destination within the standard customs procedures and handling methods off ARAMEX. ARAMEX does not warrant that any particular item to be carried is capable off carriage without infringing the law off any country or state through which the item may be carried.

4. LIMITATION OF LIABILITY
Subject to Section 6 and hereoff:

a) ARAMEX will be responsible for the consignment only while it is within ARAMEX custody and control. ARAMEX shall not be liable for loss or damage off a shipment while the shipment is out off ARAMEX custody or control. ARAMEX LIABILITY IS IN ANY EVENT LIMITED TO ONE HUNDRED DOLLARS (\$100.00) or its equivalent per shipment unless a higher value is declared on the Airway Bill at the time off tender and an additional charge is paid. However and determined by ARAMEX for each one hundred Dollars (\$100.00) or fraction thereof which the insured value designated by the customer on the Airway Bill exceeds One Hundred Dollars (\$100.00) per shipment.
b) Notwithstanding the foregoing, the customer off the time off transference a higher value than One Hundred Dollars (\$100.00) on the Airway Bill ARAMEX'S liability shall in any event be limited to the actual value off the insured value or the amount off any loss or damage actually sustained by the customer.
c) The actual value off a shipment shall be ascertained by reference to its replacement, reproduction or reconstruction value at the time and place off shipment. However in loss, without reference to its commercial utility to the customer or to other items off consequential loss.
d) NOTWITHSTANDING ANY OF THE FOREGOING, THE MAXIMUM INSURED VALUE ON ANY SHIPMENT ACCEPTED BY ARAMEX IS TEN THOUSAND DOLLARS (\$10,000.00) AND IN NO EVENT SHALL THE LIABILITY OF ARAMEX EXCEED THAT AMOUNT.

5. CONSEQUENTIAL DAMAGES EXCLUDED
ARAMEX SHALL NOT BE LIABLE IN ANY EVENT, FOR ANY CONSEQUENTIAL OR SPECIAL OR INCIDENTAL DAMAGE OR OTHER INDIRECT LOSS HOWEVER ARISING, WHETHER OR NOT ARAMEX HAD KNOWLEDGE THAT SUCH DAMAGE MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO, LOSS OF INCOME, PROFITS, INTEREST, UTILITY OR LOSS OF MARKET.

6. LIABILITY NOT ASSUMED
ARAMEX shall not be liable for any loss, damage, delay, misdelivery or non-delivery not caused by its own negligence or for any loss, damage, delay, misdelivery or non-delivery caused by:

i. the act, fault or omission off the shipper or consignee or any other party who claims an interest in the shipment
ii. the nature off the shipment or any characteristics or inherent vice thereof
iii. violation by the shipper or consignee off any terms or conditions, stated herein including, but not limited to, improper or insufficient packing, securing, marking or addressing, misrouting the consignment off any shipment or failure to observe any off these rules relating to the shipments not acceptable for transportation whether such rules are now or hereafter promulgated by ARAMEX
iv. Acts off God, perils off the air, or any other force majeure or other government officials, strikes or other local disturbances or incidents to a state off which the shipment is consigned or temperature or atmospheric changes or conditions or mechanical or other delay off any aircraft used in providing transportation services or any other cause reasonably beyond the control off ARAMEX
v. Acts or omissions off any postal or governmental or other authority or any other entity to whom a shipment is tendered by ARAMEX for transportation off whether the shipper requested or had knowledge off such third party delivery requirements
vi. Electrical or magnetic injury, seizure, or other such damage to electronic or photographic images or recordings in any form due to insects or vermin

vii. While ARAMEX will endeavor to exercise its best efforts to provide expedient delivery in accordance with regular delivery schedules, ARAMEX will not under any circumstances be liable for delay in pickup, transportation or delivery off any shipment regardless off the cause off such delay.

7. MATERIALS NOT ACCEPTABLE FOR TRANSPORT:
ARAMEX will not accept for transport any material which is not accepted by ARAMEX. The customer is responsible to accurately describe the shipment on this Airway Bill and to ensure that no material is delivered to ARAMEX which has been declared to be unacceptable by ARAMEX.

a) ARAMEX will not carry:
Liquor, the carriage off which is prohibited by any legislation or statute or local government off any country (other than through which the property may be carried) works off art, bullion, jewelry, precious metals, stamps, cashier's checks, money orders, securities, animals, hazardous or radioactive material, lead, arsenic or pyrophoric material, hazardous or combustible material, industrial carbon and diamonds.
b) The event that any customer should consign to ARAMEX any such material as described above, or any item which the customer has undervalued for customs purposes or misdeclared whether intentionally or otherwise, the customer shall indemnify and hold ARAMEX harmless from all charges, fines and expenses arising in connection therewith. ARAMEX shall have the right to abandon such property after release possession off said property to any agent or employee off any national or local government claiming jurisdiction over such materials immediately upon ARAMEX obtaining knowledge that such materials infringe these conditions. However, these conditions shall not be a bar to any off its rights reserved to it under this section without incurring liability whatsoever to the customer.
c) The customer shall be responsible for the packaging of the goods for transportation. The customer's responsibility includes the packing off the goods or documents in any container which may be supplied to the customer. ARAMEX accepts no responsibility for loss or damage to documents or goods caused by inadequate or inappropriate packing. The sole responsibility off the customer to address adequately each consignment off documents or goods to enable effective delivery to ARAMEX shall not be liable for delay in forwarding or delivery resulting from the customer's failure to comply with its obligations in this respect.

8. INSURANCE
The customer is liable for all loss, damage and expenses arising as a result off its failure to comply with its obligations under this agreement as a result off its negligence.

9. CHARGES
Any rates quoted by ARAMEX for carriage are inclusive off local airport taxes, exclude off any value added tax, levies, imposts, deposits or outlays incurred in respect off carriage off the consignment. Should the customer indicate by endorsement in the space provided on the Airway Bill that the receiver shall be liable for any customs duties, the customer shall be liable for such customs duties in the event off a default in payment by the customer. ARAMEX will not be liable for any penalties imposed or loss or damage incurred due to its customs documents or goods being impounded by customs or similar authorities and the customer hereby indemnifies ARAMEX against such penalty or loss.

10. PROPERTY
ARAMEX will carry documents or goods which are the property off the customer and the customer warrants that it is authorized to accept and is accepting these conditions not only on behalf off itself but as agent and on behalf off all other persons who are or may hereafter be interested in the documents or goods. The customer hereby undertakes to indemnify ARAMEX against any damages costs and expenses resulting from any breach off this warranty.

11. CLAIMS
ANY CLAIMS AGAINST ARAMEX MUST BE SUBMITTED IN WRITING TO THE OFFICE OF ARAMEX NEAREST THE LOCATION WHERE THE SHIPMENT WAS ACCEPTED, WITHIN SIXTY (60) DAYS OF THE DATE OF ACCEPTANCE BY ARAMEX.

12. NON-DELIVERY OF SHIPMENT
Notwithstanding the shipment to the consignee, the shipper shall be liable for all costs and expenses related to the shipment off the package off costs incurred in either returning the shipment or warehousing the shipment pending disposition.

13. INSURANCE
a) ARAMEX maintains cargo liability insurance to the full extent off the liability offered to the shipper.
b) At the request off the shipper and upon payment thereoff, at the then prevailing rate, ARAMEX will arrange insurance coverage on behalf off the shipper in an amount not exceeding Ten Thousand Dollars (\$10,000.00).
c) The insurance cover shall be governed by all the terms and conditions contained in the policy off insurance issued by insurance carrier. Certificate evidencing such insurance will be made available to the shipper.
d) CONSEQUENTIAL DAMAGES AND LOSS OR DAMAGE RESULTING FROM DELAYS IN TRANSPORTATION ARE NOT COVERED BY ANY SUCH POLICY OF INSURANCE.

14. WARSAW CONVENTION
Where the rules relating to liability established by the Warsaw Convention or the Montreal Convention apply, carriage liability is governed by and shall be limited in accordance with such rules. Subject to applicable law, where the Warsaw Convention or the Montreal Convention do not apply, liability to loss or damage is governed by these terms and conditions and shall be limited to proven damages up to an amount not exceeding 1000 / shipment.

THIS IS A NON-NEGOTIABLE AIRBILL. ALL SERVICES PROVIDED ARE SUBJECT TO THE TERMS AND CONDITIONS SET FORTH ON THE REVERSE OF SHIPPER'S COPY. BY SIGNING THIS AIRBILL, THE SHIPPER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX'S LIABILITY IS LIMITED TO US\$ 100.00 IN TENDERING THIS SHIPMENT. SHIPPER AGREES THAT ARAMEX SHALL NOT BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM THE CARRIAGE HEREOF, ARAMEX DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED WITH RESPECT TO THIS SHIPMENT.
