CONDITIONS OF CARRIAGE

In tendering the shipment for carriage, the customer agrees to these terms and conditions of carriage and that they are all **ACCEPTABLE** and has been prepared by the customer or on the customer's behalf by ARAMEX used in these conditions. ARAMEX includes Aramex and all of its operating divisions and subsidiaries.

1. SCOPE OF CONDITIONS
These conditions shall govern and apply to all services provided by ARAMEX. BY SIGNING THIS AIRBILL, THE CUSTOMER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX shall not be bound by any agreement which varies from these conditions, such agreement is in writing and signed by an authorized officer of ARAMEX. The absence of such written agreement does not constitute the entire agreement between ARAMEX and each of its customers.

2. ARAMEX'S OBLIGATIONS
ARAMEX agrees, subject to receiving payment of applicable rates and charges in effect on the date of acceptance by ARAMEX of a shipment to transport the goods from the place of origin to the place of destination in accordance with the instructions of the customer. ARAMEX reserves the right to transport the goods by any route and procedure and by successive carriers and according to its own handling and transportation methods.

3. SERVICE RESTRICTIONS
ARAMEX reserves the right to refuse any documents or parcels from any person or company at its own discretion.
ARAMEX reserves the right to abandon carriage of any shipment at any time after acceptance when such shipment could possibly cause damage or delay to other shipments registered or processed or when any such carriage is prohibited by law or is in violation of any of the rules contained herein.
ARAMEX reserves the right to open and inspect any shipment consigned by a customer to ensure that it is capable of carriage to the office or country of destination within the standard customer's regular handling methods. ARAMEX does not warrant that any particular item to be carried is capable of carriage without infringing the law of any country or state through which the item may be carried.

4. LIMITATION OF LIABILITY
Subject to Sections 5 and 6 hereof:
ARAMEX shall be responsible for the transportation of goods only while it is within ARAMEX's custody and control. ARAMEX shall not be liable for loss or damage to a shipment while in possession of the carrier or any other party who claims an interest in the shipment.
Higher value is declared on the Aramex bill at the time of tender and an additional charge is paid (determined by ARAMEX) for each one hundred Dollars (US\$100) or fraction thereof in excess of the amount value declared by the customer on the Aramex bill (maximum One Hundred Dollars (US\$100) per shipment).
ARAMEX shall not be liable for any loss or damage to a shipment if the value of the goods exceeds the amount declared on the Aramex bill.

5. CONSEQUENTIAL DAMAGES EXCLUDED
ARAMEX SHALL NOT BE LIABLE IN ANY EVENT, FOR ANY CONSEQUENTIAL OR SPECIAL OR INCIDENTAL DAMAGE OR OTHER INDIRECT LOSS HOWEVER ARISING, WHETHER OR NOT ARAMEX HAD KNOWLEDGE THAT SUCH DAMAGE MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO, LOSS OF INCOME, PROFITS, INTEREST, UTILITY OR LOSS OF MARKET.

6. LIABILITY NOT ASSUMED
ARAMEX shall not be liable for any loss, damage, delay, misdelivery or non-delivery caused by:
i. the acts, faults or omissions of the shipper or consignee or any other party who claims an interest in the shipment
ii. the nature of the shipment or any of its contents or inherent vice thereof
iii. violation by the shipper or consignee of any law or regulation, statute, ordinance, regulation or rule, including but not limited to, dangerous or hazardous goods, marking or addressing, mislabeling the contents, off any shipment or failure to observe any of these rules relating to the shipment not acceptable for transportation whether such rules are now or hereafter promulgated by ARAMEX.

7. Acts of God, ports of call, etc.
ARAMEX shall not be liable for any loss, damage, delay, misdelivery or non-delivery caused by:

ARAMEX will not accept for carriage from time to time to certain classes of materials which are not accepted by ARAMEX. The customer is responsible to accurately describe the shipment on this bill and to ensure that no materials are delivered to ARAMEX which has been declared to be unacceptable by ARAMEX.

8. PACKAGING
The customer is liable for all transportation and expenses arising as a result of its failure to comply with its obligations under this agreement as a result of its negligence.

9. INSURANCE
ARAMEX maintains cargo liability insurance to the full extent of the liability offered to the shipper.
At the request of the shipper and upon payment thereof at the time of presentation, ARAMEX will arrange insurance coverage on behalf of the shipper in an amount not exceeding Ten Thousand Dollars (US\$10,000).

12. PROPERTY
ARAMEX will only carry documents or goods which are the property of the customer and the customer warrants that it is authorized to accept and is accepting these conditions not only on behalf of itself but as agent and on behalf of all other persons who are or may hereafter be interested in the goods. The customer hereby undertakes to indemnify ARAMEX against any damages, costs and expenses resulting from any breach of this warranty.

13. CLAIMS
ANY CLAIM AGAINST ARAMEX MUST BE SUBMITTED IN WRITING TO THE OFFICE OF ARAMEX NEAREST THE LOCATION WHERE THE SHIPMENT WAS ACCEPTED, WITHIN SIXTY (60) DAYS OF THE DATE OF ACCEPTANCE BY ARAMEX.

14. NON-DELIVERY OF SHIPMENT
Notwithstanding the above, the carrier/shipper shall be liable for all costs and expenses related to the shipment of the goods, including but not limited to, the cost of storage, handling, and other expenses incurred in either returning the shipment or warehousing the shipment pending disposition.

15. INSURANCE
