### CONDITIONS OF CARRIAGE

In accepting the shipment, the customer agrees to these terms and conditions of carriage and that they are irrevocable and has been prepared by the customer or the authorized agent of ARAMEX used in these conditions. ARAMEX, its divisions and subsidiaries, ARAMEX LTD and their respective agents, officers and employees.

**1. SCOPE OF CONDITIONS:**  
These conditions of carriage apply to all services provided by ARAMEX. SIGNING THIS AIRBILL, THE CUSTOMER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX shall not be bound by any agreement which varies from these conditions. Such agreement is in writing and signed by an authorized officer of ARAMEX. In the absence of such written agreement, these conditions shall constitute the entire agreement between ARAMEX and each of its customers. ARAMEX shall have the authority to alter or waive these terms and conditions as stated herein.

**2. ARAMEX'S OBLIGATIONS:**  
ARAMEX agrees, subject to receiving payment of applicable rates and charges in full, to arrange for the transportation of the shipment between the destination agreed upon by ARAMEX and the customer. ARAMEX reserves the right to suspend, modify, terminate or discontinue any route and procedure by its successive carriers and according to its own handling system and transportation methods.

**3. SERVICE RESTRICTION:**  
ARAMEX reserves the right to refuse any document or parcel from any person or company at its own discretion.  
ARAMEX reserves the right to abandon carriage of any shipment after acceptance when such shipment could possibly cause damage or delay to other shipments.  
ARAMEX reserves the right to open and inspect any shipment consigned by a customer to ensure that it is capable of carriage to the stated or country of destination within the standard customs procedures and handling methods. ARAMEX reserves the right to refuse to carry any particular item to be carried in excess of capacity without incurring the law of any country or state through which the item may be carried.

**4. LIMITATION OF LIABILITY:**  
Subject to Section 6 and 8 herein:  
ARAMEX will be responsible for the cargo from the time it is within ARAMEX's custody and control. ARAMEX shall not be liable for loss or damage of a shipment where the maximum amount of ARAMEX'S LIABILITY IN ANY EVENT LIMITED TO ONE HUNDRED DOLLARS (US\$100) or its equivalent per shipment unless a higher value is declared on the Airway Bill and an additional charge is paid. Losses and damages determined by ARAMEX for each one hundred Dollars (US\$100) or less, whichever is the lesser value designated by the customer on the Airway Bill exceeds One Hundred Dollars (US\$100) per shipment.  
ARAMEX's liability shall be limited to the lesser of the insured value or the amount of loss or damage actually sustained by the customer.  
The actual value of a shipment shall be determined by reference to its replacement value or reconstruction value at the time and place of loss or damage, whichever is less without reference to the insured value of the shipment or to other items of similar nature.

**5. NOTWITHSTANDING ANY OF THE FOREGOING, THE MAXIMUM INSURED VALUE ON ANY SHIPMENT ACCEPTED BY ARAMEX IS TEN THOUSAND DOLLARS (US\$10,000.00) AND IN NO EVENT SHALL THE LIABILITY OF ARAMEX EXCEED THIS AMOUNT.**

**5. CONSEQUENTIAL DAMAGES EXCLUDED:**  
ARAMEX SHALL NOT BE LIABLE, IN ANY EVENT, FOR ANY CONSEQUENTIAL OR SPECIAL OR EXEMPLARY DAMAGES OF OTHER NATURE (LOSS OF PROFITS, LOSS OF BUSINESS, LOSS OF REVENUE, LOSS OF INCOME, PROFITS, INTEREST, COST OF LOSS OR OTHERWISE) THAT SUCH DAMAGES MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO, SUCH DAMAGES.

**6. LIABILITY NOT ASSIGNED:**  
ARAMEX shall not be liable for any loss, damage, delay, modification or non-delivery not caused by its own negligence. The sole responsibility for any loss, damage, delay, modification or non-delivery caused by:  
1. The act, fault or omission of the shipper or consignee or any other party who claims an interest in the shipment.  
2. The act, fault or omission of any other person or party who claims an interest in the shipment.  
3. The act, fault or omission of any other person or party who claims an interest in the shipment.
