### CONDITIONS OF CARRIAGE

In tendering the shipment, the customer agrees to these terms and conditions of carriage and that this air bill is negotiable and shall be prepared by the customer or on the customer's behalf by ARAMEX used in these conditions. ARAMEX includes Aramex Logistics operating divisions and subsidiaries of Aramex Ltd and their respective agents, servants, officers and employees.

**1. SCOPE OF CONDITIONS**  
These conditions shall govern and apply to all services provided by ARAMEX. SIGNING THIS AIRBILL, THE CUSTOMER KNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX shall not be bound by any agreement which varies from these conditions, such agreement is in writing and signed by an authorized officer of ARAMEX. The receiver of such written agreement, these conditions shall constitute the entire agreement between ARAMEX and each of its customers. ARAMEX shall have the authority to alter or waive these terms and conditions as stated herein.

**2. ARAMEX'S OBLIGATIONS**  
ARAMEX hereby undertakes to receive payment of applicable rates and charges in effect on the date of acceptance by ARAMEX of a shipment to arrange for the transportation of the shipment within the country agreed upon by ARAMEX and the customer. ARAMEX reserves the right to transport the consignment by any route and procedure and by successive carriers and according to its own hand, rights and transportation methods.

**3. STRICT RESTRICTION**  
ARAMEX reserves the right to refuse any documents or parcels from any person or company on its own discretion.  
ARAMEX reserves the right to abandon carriage of any shipment at any time after acceptance when such shipment could possibly cause damage or delay to other shipments registered or processed or when such carriage is prohibited by law or is in violation of any other rules contained herein.  
ARAMEX reserves the right to open and inspect any shipment conveyed by a customer to ensure that it is capable of carriage to the state or country of destination within the standard customs procedures and handling methods of ARAMEX. ARAMEX does not warrant that any particular item to be carried is capable of carriage without stopping the law of any country or state through which the item may be carried.

**4. LIMITATION OF LIABILITY**  
Subject to the terms and conditions hereof:  
ARAMEX shall be responsible for the customer's liability while it is within ARAMEX custody and control. ARAMEX shall not be liable for loss or damage of a shipment while in possession of ARAMEX or its agents. ARAMEX'S LIABILITY IS IN ANY EVENT LIMITED TO ONE HUNDRED DOLLARS (US\$100.00) or its equivalent per shipment unless a higher value is declared on the Airway Bill at the time of tender and an additional charge is paid. (ARAMEX shall not be liable for any loss or damage in excess of the value of the goods or the amount of the insured value of the goods, whichever is less, in any event to exceed the amount of the insured value or the amount of loss or damage actually sustained by the customer.)  
If the actual value of the shipment that is carried is higher than the insured value, the customer shall be liable for the difference between the actual value and the insured value.  
If the actual value of the shipment that is carried is less than the insured value, the customer shall be liable for the difference between the actual value and the insured value.  
If the actual value of the shipment that is carried is less than the insured value, the customer shall be liable for the difference between the actual value and the insured value.

**5. CONSEQUENTIAL DAMAGES EXCLUDED**  
ARAMEX SHALL NOT BE LIABLE IN ANY EVENT, FOR ANY CONSEQUENTIAL OR SPECIAL OR INCIDENTAL DAMAGE OR OTHER INDIRECT LOSS HOWSOEVER ARISING, WHETHER OR NOT ARAMEX HAD KNOWLEDGE THAT SUCH DAMAGE MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO LOSS OF INCOME, PROFITS, INTEREST, UTILITY OR LOSS OF MARKET.

**6. LIABILITY NOT ASSUMED**  
ARAMEX shall not be liable for any loss, damage, delay, misdelivery or nondelivery not caused by its own negligence. For any loss, damage, delay, misdelivery or non-delivery caused by:  
1. The act of God or omission of the shipper or consignee or any other party who claims an interest in the shipment.  
2. The nature of the shipment or any defect in the shipment or inherent vice thereof.  
3. Violation by the shipper or consignee of any laws or regulations, without limiting to the provisions of these conditions, relating to the shipment, whether such laws are now or hereafter promulgated by ARAMEX.

**7. Acts of God, perils of the air, communicable diseases acting with actual or apparent authority or laws or omission of postal authorities or other government officials, strikes or other local disturbances, incidents of piracy or other conditions, without limiting to the provisions of these conditions, relating to the shipment, whether such laws are now or hereafter promulgated by ARAMEX.**

**8. Acts of God, perils of the air, communicable diseases acting with actual or apparent authority or laws or omission of postal authorities or other government officials, strikes or other local disturbances, incidents of piracy or other conditions, without limiting to the provisions of these conditions, relating to the shipment, whether such laws are now or hereafter promulgated by ARAMEX.**

**9. While ARAMEX will endeavor to exercise its best efforts to provide expedited delivery in accordance with regular delivery schedules, ARAMEX will not under any circumstances be liable for delay in transportation or delivery of any shipment regardless of the cause of such delay.**

**7. MATERIALS NOT ACCEPTABLE FOR TRANSPORT**  
ARAMEX will not accept for shipment from time to time as the carrier classes of materials which are not accepted by ARAMEX. The customer is responsible to accurately describe the shipment on this bill and to ensure that no material is delivered to ARAMEX which has been declared to be unacceptable by ARAMEX.

**8. PACKAGING**  
The packaging of the customer's documents or goods for transportation is the customer's responsibility including the placing of the goods or documents in any container which may be required by the customer. ARAMEX accepts no responsibility for loss or damage to documents or goods caused by inadequate or inappropriate packaging. The sole responsibility of the customer to address adequately any consequential loss of documents or goods to ensure effective delivery to ARAMEX shall not be liable for delay in forwarding or delivery resulting from the customer's failure to comply with its obligations in this respect.

**9. NEGLIGENCE**  
The customer is liable for all losses, damages and expenses arising as a result of its failure to comply with its obligations under this agreement as a result of its negligence.

**10. CHARGES**  
Any rates quoted by ARAMEX for carriage are inclusive of local airport taxes, exclusive of any value added tax, duties, taxes, import duties or duties incurred in respect of carriage of the customer's goods. Should the customer indicate by endorsement on the invoice provided on the bill that the receiver shall be liable for any customs duties or taxes on such goods, the customer shall be responsible for the payment of such duties and taxes. In payment by the customer, ARAMEX will not be liable for any penalties imposed or loss or damage incurred due to the customer's documents or goods being impounded by customs or similar authorities and the customer hereby indemnifies ARAMEX against such penalty or loss.

**11. PROPERT**  
ARAMEX will carry documents or goods which are the property of the customer and the customer warrants that it is authorized to accept and is accepting these conditions not only on behalf of itself but as agent and on behalf of all other persons who are or may hereafter be interested in the documents. The customer hereby undertakes to indemnify ARAMEX against all damages and expenses resulting from any breach of this warranty.

**12. CLAIMS**  
ANY CLAIMS AGAINST ARAMEX MUST BE SUBMITTED IN WRITING TO THE OFFICE OF ARAMEX NEAREST THE LOCATION WHERE THE SHIPMENT WAS ACCEPTED, WITHIN SIXTY (60) DAYS OF THE DATE OF ACCEPTANCE BY ARAMEX.

**13. NON-DELIVERY OF SHIPMENT**  
Notwithstanding the above, the customer shall be liable for all costs and expenses related to the shipment of the goods if the goods are not delivered to the destination or are returned to the shipper or are held in a warehouse pending disposition.

**14. INSURANCE**  
ARAMEX maintains cargo liability insurance to the full extent of the liability offered to the shipper.  
If the request of the shipper and upon payment thereof at the time of acceptance, ARAMEX will arrange insurance coverage on behalf of the shipper in an amount not exceeding the insured value of the goods.  
The insurance cover shall be governed by all the terms and conditions contained in the policy of insurance issued by insurance carrier. The customer shall be liable for the cost of such insurance.

**15. CONSEQUENTIAL DAMAGES AND LOSS OR DAMAGE RESULTING FROM DELAYS IN TRANSPORTATION ARE NOT COVERED BY ANY SUCH POLICY OF INSURANCE.**

**16. WARSAW CONVENTION**  
Where the rules relating to the liability established by the Warsaw Convention or the Montreal Convention apply, the carrier's liability is governed by and shall be limited in accordance with such rules. Subject to the applicable law, the Warsaw Convention or the Montreal Convention shall not apply to the extent that it is inconsistent with these conditions and shall be limited to the extent that it is inconsistent with these conditions.

**17. THIS IS A NON-NEGOTIABLE AIRBILL. ALL SERVICES PROVIDED ARE SUBJECT TO THE TERMS AND CONDITIONS SET FORTH ON THE REVERSE OF SHIPPER'S COPY. BY SIGNING THIS AIRBILL, THE SHIPPER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX'S LIABILITY IS LIMITED TO US\$ 100.00 IN TENDERING THIS SHIPMENT. SHIPPER AGREES THAT ARAMEX SHALL NOT BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM THE CARRIAGE HEREOF, ARAMEX DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED WITH RESPECT TO THIS SHIPMENT.**
