CONDITIONS OF CARRIAGE

1. Involving the shipment, the carrier/customer agrees to these terms and conditions of carriage and that this is not negotiable and has been prepared by the customer or on the customer's behalf by ARAMEX used in these conditions. ARAMEX includes Aramex Co. Ltd as operating divisions and subsidiaries of Aramex Ltd and their respective agents/officers and employees.

2. ARAMEX'S OBLIGATIONS
ARAMEX agrees to receive payments of applicable rates and charges in effect on the date of acceptance by ARAMEX of a shipment to arrange for the transportation of the shipment between the locations agreed upon by ARAMEX and the customer.

3. SERVICE RESTRICTION
a) ARAMEX reserves the right to refuse any documents or parcels from any person or company at its own discretion.
b) ARAMEX reserves the right to abandon carriage of any shipment at any time after acceptance when such shipment could possibly cause damage or delay to other shipments.
c) ARAMEX reserves the right to open and inspect any shipment consigned by a customer to ensure that it is capable of carriage to the place or country of destination within the standard customs procedures and handling methods. ARAMEX exercising this right/ARAMEX does not warrant that any particular item to be carried is capable of carriage without infringing the law of any country or state through which the item may be carried.

4. LIMITATION OF LIABILITY
Subject to Section 6 hereof:
a) ARAMEX shall be responsible for the customer's/shipment only value in its within ARAMEX's custody and control. ARAMEX shall not be liable for loss or damage of a shipment while in possession of ARAMEX's custody or control. ARAMEX'S LIABILITY IN ANY EVENT LIMITED TO ONE HUNDRED DOLLARS (US\$100.00) or its equivalent per shipment unless a higher value is declared on the Airway Bill at the time of tender and an additional charge is paid. Uninsured and determined by ARAMEX for each one Hundred Dollars (US\$100.00) or fraction thereof which the insured value designated by the customer on the Airway Bill exceeds One Hundred Dollars (US\$100.00) per shipment.
b) Notwithstanding the foregoing, the customer's liability shall in any event be limited to the lower of the insured value or the amount of any loss or damage actually sustained by the customer.
c) The actual value of a shipment shall be ascertained by reference to its replacement or reconstruction value at the time and place of shipment. However, in the absence of such information, the value shall be the value of the goods at the time and place of shipment.
d) NOTWITHSTANDING ANY OF THE FOREGOING, THE MAXIMUM INSURED VALUE ON ANY SHIPMENT ACCEPTED BY ARAMEX IS TEN THOUSAND DOLLARS (US\$10,000.00) AND IN NO EVENT SHALL THE LIABILITY OF ARAMEX EXCEED THAT AMOUNT.

5. CONSEQUENTIAL DAMAGES EXCLUDED
ARAMEX SHALL NOT BE LIABLE IN ANY EVENT, FOR ANY CONSEQUENTIAL OR SPECIAL OR INCIDENTAL DAMAGE OR OTHER INDIRECT LOSS HOWSOEVER ARISING, WHETHER OR NOT ARAMEX HAD KNOWLEDGE THAT SUCH DAMAGE MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO LOSS OF INCOME, PROFITS, INTEREST, SALES OR LOSS OF MARKET.

6. LIABILITY NOT ASSIGNED
ARAMEX shall be not liable for any loss/damage, delay, misdelivery or non-delivery not caused by its own negligence. For any loss/damage, delay, misdelivery or non-delivery caused by:
1. the shipper/consignor or any other party who claims an interest in the shipment
2. the nature of the shipment or any defect/characteristic or inherent vice thereof
3. violation by the shipper or consignee of any laws or regulations, stipulated herein including but not limited to dangerous or insufficient packing, securing, marking or addressing, misidentifying the contents of any shipment or failure to observe any of these rules relating to the shipment's status acceptable for transportation/whether such rules are now or hereafter promulgated by ARAMEX
4. Acts of God, parts off the air, electromagnetic authorities acting with actual or apparent authority or laws or omission of postal authorities or other government officials, strikes or other local disputes and incidents in a state of weather conditions, transportation or atmospheric changes or conditions mechanical or other equipment off any aircraft used in providing transportation services or in any other case reasonable beyond the control of ARAMEX
5. Acts or omissions of any postal service/forwarder or any other entity to whom a shipment is tendered by ARAMEX for transportation/whether off whether the shipper requested or had knowledge of such third party delivery requirement.
6. Electrical or magnetic injury, or other such damage to electronic or photographic images or recordings in any form/damage due to insects or vermin.
7. While ARAMEX will endeavor to exercise its best efforts to provide expeditious delivery in accordance with regular delivery schedule/ARAMEX will not under any circumstances be liable for delay in pickup/transportation or delivery of any shipment regardless of the causes of such delay.

7. MATERIALS NOT ACCEPTABLE FOR TRANSPORT
ARAMEX will not accept for transport any material which is not accepted by ARAMEX. The customer is responsible to accurately describe the shipment on this AWB and to ensure that no material is delivered to ARAMEX which has been declared to be unacceptable by ARAMEX.

8. PACKAGING
The packaging of the customer's documents or goods for transportation is the customer's responsibility including the placing of the goods or documents in any container which may be supplied by the customer. ARAMEX/ARAMEX accepts no responsibility for loss or damage to documents or goods caused by inadequate or inappropriate packaging. The sole responsibility of the customer to address adequately such consignment of documents or goods to enable effective delivery to the customer shall not be liable for delay in forwarding or delivery resulting from the customer's failure to comply with its obligations in this respect.

9. NEGLIGENCE
The customer is liable for all loss/damage and expenses arising as a result of its failure to comply with its obligations under this agreement as a result of its negligence.

10. CHARGES
Any rates quoted by ARAMEX for carriage are inclusive of local airport taxes exclusive of any value added tax, duties, levies, imposts, deposits or surcharges incurred in respect of carriage off the customer's goods. Should the customer's liability by endorsement in the space provided on the AWB that the receiver shall be liable for any customs/duties/taxes shall be liable for such customs duty or tax except off a default in payment by the receiver. ARAMEX will not be liable for any penalties imposed or loss or damage incurred due to the customs/documents or goods being impounded by customs or similar authorities and the customer hereby indemnifies ARAMEX against such penalty or loss.

11. PROPERTY
ARAMEX will only carry documents or goods which are the property of the customer and the customer warrants that it is authorized to accept and is accepting these conditions not only on behalf of itself but as a agent and on behalf of all other persons who are or may hereafter be interested in the document/the customer hereby undertakes to indemnify ARAMEX against any damages costs and expenses resulting from any breach of this warranty.

12. CLAIMS
ANY CLAIMS AGAINST ARAMEX MUST BE SUBMITTED IN WRITING TO THE OFFICE OF ARAMEX NEAREST THE LOCATION WHERE THE SHIPMENT WAS ACCEPTED, WITHIN FIFTY (50) DAYS OF THE DATE OF ACCEPTANCE BY ARAMEX.

13. NON-DELIVERY OF SHIPMENT
Notwithstanding the shipper's instruction to the contrary, the shipper shall be liable for all costs and expenses related to the shipment off the shipper's costs incurred in either returning the shipment or warehousing the shipment pending disposition.

14. INSURANCE
a) ARAMEX maintains cargo liability insurance to the full extent of the liability provided to the shipper.
b) At the request of the shipper and upon payment therefor at the time of presentation, ARAMEX will arrange insurance coverage on behalf of the shipper in an amount not exceeding Ten Thousand Dollars (US\$10,000.00).
c) The insurance cover shall be governed by all the terms and conditions contained in the policy off insurance issued by insurance carrier/Carrier/Plate evidencing such insurance will be made available to the shipper.

15. WARSAW CONVENTION
Where the rules relating to the liability established by the Warsaw convention or the Montreal convention apply, carrier's liability is governed by and shall be limited in accordance with such rules. Subject to applicable law, where the Warsaw convention or the Montreal convention do not apply, liability for loss or damage is governed by these terms and conditions and shall be limited to proven damages up to an amount not exceeding US\$10,000 per shipment.

SHIPPER AGREES THAT ARAMEX SHALL NOT BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM THE CARRIAGE HEREOF. ARAMEX DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED WITH RESPECT TO THIS SHIPMENT.
