**CONDITIONS OF CARRIAGE**

1. IN TENDERING THE SHIPMENT FOR CARRIAGE THE CUSTOMER AGREES TO THESE TERMS AND CONDITIONS OF CARRIAGE AND THAT THIS AIRBILL IS NON-NEGOTIABLE AND HAS BEEN PREPARED BY THE CUSTOMER OR ON THE CUSTOMER'S BEHALF BY ARAMEX USED IN THESE CONDITIONS. ARAMEX INCLUDES ARAMEX CO. LTD AND ALL OPERATING DIVISIONS AND SUBSIDIARIES OFF ARAMEX LTD AND THEIR RESPECTIVE AGENTS, OFFICERS AND EMPLOYEES.

2. SCOPE OF CONDITIONS: These conditions shall govern and apply to all services provided by ARAMEX SIGNING THIS AIRBILL. THE CUSTOMER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX SHALL NOT BE BOUND BY ANY AGREEMENT WHICH VARIES FROM THESE CONDITIONS. SUCH AGREEMENT IS IN WRITING AND SIGNED BY THE AUTHORIZED OFFICER OF ARAMEX. THE CUSTOMER'S SIGNATURE ON THIS AIRBILL SHALL CONSTITUTE THE ENTIRE AGREEMENT BETWEEN ARAMEX AND EACH OF ITS CUSTOMERS. EMPLOYEES OF ARAMEX SHALL HAVE THE AUTHORITY TO ALTER OR WAIVE THESE TERMS AND CONDITIONS AS STATED HEREIN.

3. ARAMEX'S OBLIGATIONS: ARAMEX AGREES, SUBJECT TO RECEIVING PAYMENT OF APPLICABLE RATES AND CHARGES IN EFFECT ON THE DATE OF ACCEPTANCE BY ARAMEX OF A SHIPMENT TO ARRANGE FOR THE TRANSPORTATION OFF THE SHIPMENT BETWEEN THE LOCATIONS AGREED UPON BY ARAMEX AND THE CUSTOMER. ARAMEX RESERVES THE RIGHT TO TRANSPORT THE CARGO BACKLOG BY ANY ROUTE AND PROCEDURE AND BY SUCCESSIVE CARRIERS AND ACCORDING TO ITS OWN HANDLING STORAGE AND TRANSPORTATION METHODS.

4. SERVICE RESTRICTION: a) ARAMEX reserves the right to refuse any documents or parcels from any person or company at its own discretion. b) ARAMEX reserves the right to abandon carriage off any shipment at any time after acceptance when such shipment could possibly cause damage or delay to other shipments. c) ARAMEX reserves the right to open and inspect any shipment consigned by a customer to ensure that it is capable of carriage to the state or country of destination within the standard customs procedures and handling methods off ARAMEX. d) ARAMEX does not warrant that any particular item to be carried is capable of carriage without infringing the law off any country or state through which the item may be carried.

5. LIMITATION OF LIABILITY: Subject to the sections 6 and 6 hereoff: a) ARAMEX will be responsible for the cargo/shipment only while it is within ARAMEX custody and control. ARAMEX shall not be liable for loss or damage off a shipment when the shipment is out off ARAMEX custody or control. ARAMEX'S LIABILITY IN ANY EVENT LIMITED TO ONE HUNDRED DOLLARS (US\$100.00) OR ITS EQUIVALENT PER SHIPMENT UNLESS A HIGHER VALUE IS DECLARED ON THE AIRWAY BILL AT THE TIME OFF TENDER AND AN ADDITIONAL CHARGE IS PAID. b) ARAMEX'S LIABILITY FOR EACH ONE HUNDRED DOLLAR (US\$100.00) OR EQUIVALENT THEREOFF WHICH THE INSURED VALUE DESIGNATED BY THE CUSTOMER ON THE AIRWAY BILL EXCEEDS ONE HUNDRED DOLLARS (US\$100.00) PER SHIPMENT. c) Notwithstanding the foregoing, the maximum value of the cargo/shipment shall be limited to the amount off any loss or damage actually sustained by the customer. d) The actual value off a shipment shall be ascertained by reference to its replacement value or reconstruction value at the time and place off shipment. e) ARAMEX shall, without reference to its commercial utility to the customer or to other items off consequential loss. f) NOTWITHSTANDING ANY OF THE FOREGOING, THE MAXIMUM INSURED VALUE ON ANY SHIPMENT ACCEPTED BY ARAMEX IS TEN THOUSAND DOLLARS (US\$10,000.00) AND IN NO EVENT SHALL THE LIABILITY OF ARAMEX EXCEED THAT AMOUNT.

6. CONSEQUENTIAL DAMAGES EXCLUDED: ARAMEX SHALL NOT BE LIABLE IN ANY EVENT, FOR ANY CONSEQUENTIAL OR SPECIAL OR INCIDENTAL DAMAGE OR OTHER INDIRECT LOSS HOWSOEVER ARISING, WHETHER OR NOT ARAMEX HAD KNOWLEDGE THAT SUCH DAMAGE MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO LOSS OF INCOME, PROFITS, INTEREST, UTILITY OR LOSS OF MARKET.

7. LIABILITY NOT ASSUMED: a) ARAMEX shall not be liable for any loss, damage, delay, misdelivery or non-delivery not caused by its own negligence. b) For any loss, damage, delay, misdelivery or non-delivery caused by: i. the act of God, perils off the air, or any other party who claims an interest in the shipment. ii. the nature off the shipment or any defect in the shipment or inherent vice thereof. iii. violation by the shipper or consignee off any terms or conditions stated herein including, but not limited to improper or insufficient packing, securing, marking or addressing, misdescribing the contents off any shipment or failure to observe any of these rules relating to the shipment not acceptable for transportation whether such rules are now or hereafter promulgated by ARAMEX. iv. Acts off God, perils off the air, or any other party who claims an interest in the shipment or any other government officials, strikes or other local disturbances incidents to a state off, whether conditions temperature or atmospheric changes or conditions mechanical or other delay off any aircraft used in providing transportation services or any other cause reasonably beyond the control off ARAMEX. v. Acts or omissions off any postal service/forwarder or any other entity to whom a shipment is tendered by ARAMEX for transportation/off whether the shipper requests or had knowledge off such third party delivery requirement. vi. Electrical or magnetic injury, or other such damage to electronic or photographic images or recordings in any form/damage due to insects or vermin. c) While ARAMEX will endeavour to exercise its best efforts to provide expeditious delivery in accordance with regular delivery schedule, ARAMEX will not under any circumstances be liable for delay in pickup/transportation or delivery off any shipment regardless off the causes off such delay.

8. MATERIALS NOT ACCEPTABLE FOR TRANSPORT: ARAMEX will not carry cargo from time to time as to certain classes off materials which are not accepted by ARAMEX. The customer's responsibility to accurately describe the shipment on this Airbill and to ensure that no material is delivered to ARAMEX which has been declared to be unacceptable by ARAMEX. a) ARAMEX will not carry: i) Property the carriage off which is prohibited by any legislation or statute or local government off any country. ii) Through which the property may be carried: firearms, bullet, poison, work off art, negotiable instruments in bearer form, jewelry, precious metals, stamps, old coins or porographic material, cash/ir's checks, money orders, deeds, travelers checks, hazardous or combustible material, antiques, plants, animals, industrial carbon and diamonds. c) In the event that any customer should consign to ARAMEX any such materials described above, or any item which the customer has undervalued for customs purposes or misdescribed whether intentionally or otherwise the customer shall indemnify and hold ARAMEX harmless from all damages, fines and expenses arising in connection therewith. ARAMEX shall have the right to abandon such property and/or release possession off said property to any agent or employee off any national or local government claiming jurisdiction over such materials immediately upon ARAMEX obtaining knowledge that such materials infringing these conditions have been turned over to ARAMEX. shall be free to exercise any off its rights reserved to it under this section without incurring liability whatsoever to the customer.

9. PACKAGING: The packaging off the cargo/documents or goods for transportation is the customer's responsibility including the placing off the goods or documents in any container which may be supplied by the customer. ARAMEX/ARAMEX accepts no responsibility for loss or damage to documents or goods caused by inadequate or inappropriate packaging. The sole responsibility off the customer to address adequately each consignment off documents or goods to enable effective delivery to the customer. ARAMEX shall not be liable for delay in forwarding or delivery resulting from the customer's failure to comply with its obligations in this respect.

10. NEGLIGENCE: The customer is liable for all losses/damages and expenses arising as a result off its failure to comply with its obligations under this agreement as a result off its negligence.

11. CHARGES: Any rates quoted by ARAMEX for carriage are inclusive off local airport taxes exclusive off any value added taxes, duties, levies, imposts, deposits or outlays incurred in respect off carriage off the customer's goods. Should the customer indicate by endorsement in the space provided on the airbill that the receiver shall be liable for any customs/duties/taxes shall be liable for such customs duty in the event off a default in payment by the receiver. ARAMEX will not be liable for any penalties imposed or loss or damage incurred due to the customer's documents or goods being impounded by customs or similar authorities and the customer hereby indemnifies ARAMEX against such penalty or loss.

12. PROPERTY: ARAMEX will only carry documents or goods which are the property off the customer and the customer warrants that it is authorized to accept and is accepting these conditions not only on behalf off itself but as agent and on behalf off all other persons who are or may hereafter be interested in the document. The customer hereunder undertakes to indemnify ARAMEX against any damages and expenses resulting from any breach off this warranty.

13. CLAIMS: ANY CLAIMS AGAINST ARAMEX MUST BE SUBMITTED IN WRITING TO THE OFFICE OF ARAMEX NEAREST THE LOCATION WHERE THE SHIPMENT WAS ACCEPTED, WITHIN SIXTY (60) DAYS OF THE DATE OF ACCEPTANCE BY ARAMEX.

14. NON-DELIVERY OF SHIPMENT: Notwithstanding the shipper's instruction to the contrary, the shipper shall be liable for all costs and expenses related to the shipment off the package's costs incurred in either returning the shipment or warehousing the shipment pending disposition.

15. INSURANCE: a) ARAMEX maintains cargo liability insurance to the full extent off the liability offered to the shipper. b) At the request off the shipper and upon payment thereoff, the then prevailing ARAMEX will arrange insurance coverage on behalf off the shipper in an amount not exceeding Ten Thousand Dollars (10,000.00). c) The insurance cover shall be governed by all the terms and conditions contained in the policy off insurance issued by insurance carrier/certificate evidencing such insurance will be made available to the shipper. d) CONSEQUENTIAL DAMAGES AND LOSS OR DAMAGE RESULTING FROM DELAYS IN TRANSPORTATION ARE NOT COVERED BY ANY SUCH POLICY OF INSURANCE.

16. WARSAW CONVENTION: "Where the rules relating to liability established by the Warsaw convention or the cmr convention apply, liability is governed by and shall be limited in accordance with such rules. Subject to applicable law, the Warsaw convention or the cmr convention do not apply to liability to loss or damage is governed by these terms and conditions and shall be limited to proven damages up to an amount not exceeding 1000 (one thousand) dollars per shipment." THIS IS A NON-NEGOTIABLE AIRBILL. ALL SERVICES PROVIDED ARE SUBJECT TO THE TERMS AND CONDITIONS SET FORTH ON THE REVERSE OF SHIPPER'S COPY. BY SIGNING THIS AIRBILL, THE SHIPPER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX'S LIABILITY IS LIMITED TO US\$ 100.00. IN TENDERING THIS SHIPMENT, SHIPPER AGREES THAT ARAMEX SHALL NOT BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM THE CARRIAGE HEREOF, UNLESS ARAMEX DISCLOSES ALL WARRANTIES, EXPRESS OR IMPLIED WITH RESPECT TO THIS SHIPMENT.
