IF ANY PROVISION OF THIS AGREEMENT IS HELD TO BE UNLAWFUL OR UNENFORCEABLE, THE REMAINDER OF THIS AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT.

100. GOVERNING LAW

THIS AGREEMENT SHALL BE GOVERNED BY THE LAWS OF SRI LANKA.
