CONDITIONS OF CARRIAGE

1. BY ACCEPTING THIS AIRWAYBILL, THE CUSTOMER AGREES TO THESE TERMS AND CONDITIONS OF CARRIAGE AND THAT THIS AIRWAYBILL IS VALID AND BINDING ON THE CUSTOMER AND ON THE CARRIER(S) BY ARAMEX. ARAMEX INCLUDES ARAMEX AND ALL OPERATING DIVISIONS AND SUBSIDIARIES OF ARAMEX AND THEIR RESPECTIVE AGENTS, OFFICERS AND EMPLOYEES.

2. SCOPE OF CONDITIONS

These conditions shall govern and apply to all services provided by ARAMEX. SIGNING THIS AIRBILL, THE CUSTOMER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX SHALL NOT BE BOUND BY ANY AGREEMENT WHICH VARIES FROM THESE CONDITIONS. THIS AGREEMENT IS IN WRITING AND SIGNED BY AN AUTHORIZED OFFICER OF ARAMEX. IN THE ABSENCE OF SUCH WRITTEN AGREEMENT, THESE CONDITIONS SHALL CONSTITUTE THE ENTIRE AGREEMENT BETWEEN ARAMEX AND EACH OF ITS CUSTOMERS.

3. ARAMEX'S OBLIGATIONS

ARAMEX SHALL HAVE THE AUTHORITY TO ALTER OR WAIVE THESE TERMS AND CONDITIONS AS STATED HEREIN.

ARAMEX AGREES, SUBJECT TO RECEIVING PAYMENT OF APPLICABLE RATES AND CHARGES IN EFFECT ON THE DATE OF ACCEPTANCE BY ARAMEX OFF A SHIPMENT, TO ARRANGE FOR THE TRANSPORTATION OF THE SHIPMENT BETWEEN THE LOCATIONS AGREED UPON BY ARAMEX AND THE CUSTOMER.

ARAMEX RESERVES THE RIGHT TO TRANSPORT THE CARGO BY AIR AND/OR BY SEA AND/OR BY SUCCESSIVE CARRIERS AND ACCORDING TO ITS OWN HANDLING AND TRANSPORTATION METHODS.

4. LIMITATION OF LIABILITY

Subject to sections 5 and 6 hereof:

a) ARAMEX WILL BE RESPONSIBLE FOR THE CARGO SHIPMENT ONLY WHILE IT IS WITHIN ARAMEX CUSTODY AND CONTROL. ARAMEX SHALL NOT BE LIABLE FOR LOSS OR DAMAGE OF A SHIPMENT WHILE THE SHIPMENT IS OUT OF ARAMEX'S CUSTODY OR CONTROL. ARAMEX'S LIABILITY IN ANY EVENT LIMITED TO ONE HUNDRED DOLLARS (US\$100.00) OR ITS EQUIVALENT PER SHIPMENT UNLESS A HIGHER VALUE IS DECLARED ON THE AIRWAYBILL AT THE TIME OF TENDER AND AN ADDITIONAL CHARGE IS PAID. BASIS AND DETERMINED BY ARAMEX. (FOR EACH ONE HUNDRED DOLLARS (US\$100.00) OR EQUIVALENT THEREOF WHICH THE INSURED VALUE DECLARED BY THE CUSTOMER ON THE AIRWAYBILL EXCEEDS ONE HUNDRED DOLLARS (US\$100.00) PER SHIPMENT.

b) WITHOUT LIMITING THE FOREGOING, THE CUSTOMER'S TIME OF TENDERANCE IS A HIGHER VALUE THAN ONE HUNDRED DOLLARS (US\$100.00) ON THE AIRWAYBILL, ARAMEX'S LIABILITY SHALL IN ANY EVENT BE LIMITED TO THE LOWER OF THE INSURED VALUE OR THE AMOUNT OF LOSS OR DAMAGE ACTUALLY SUSTAINED BY THE CUSTOMER.

c) THE ACTUAL VALUE OF A SHIPMENT SHALL BE ASCERTAINED BY REFERENCE TO ITS RECONSTRUCTION OR REPRODUCTION VALUE AT THE TIME AND PLACE OFF SHIPMENT. THERE IS, WITHOUT REFERENCE TO ITS COMMERCIAL UTILITY TO THE CUSTOMER OR TO OTHER ITEMS OF, CONSEQUENTIAL LOSS.

d) NOTWITHSTANDING ANY OF THE FOREGOING, THE MAXIMUM INSURED VALUE OF ANY SHIPMENT ACCEPTED BY ARAMEX IS TEN THOUSAND DOLLARS (US\$10,000.00) AND IN NO EVENT SHALL THE LIABILITY OF ARAMEX EXCEED THAT AMOUNT.

5. CONSEQUENTIAL DAMAGES EXCLUDED

ARAMEX SHALL NOT BE LIABLE IN ANY EVENT, FOR ANY CONSEQUENTIAL OR SPECIAL OR INCIDENTAL DAMAGE OR OTHER INDIRECT LOSS, HOWEVER ARISING, WHETHER OR NOT ARAMEX HAD KNOWLEDGE THAT SUCH DAMAGE MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO, LOSS OF INCOME, PROFITS, INTEREST, UTILITY OR LOSS OF MARKET.

6. LIABILITY NOT ASSUMED

ARAMEX SHALL NOT BE RESPONSIBLE FOR ANY LOSS, DAMAGE, DELAY, MISDELIVERY OR NON-DELIVERY NOT CAUSED BY ITS OWN NEGLIGENCE. FOR ANY LOSS, DAMAGE, DELAY, MISDELIVERY OR NON-DELIVERY CAUSED BY:

a) THE NEGLIGENCE OR NEGLIGENCE OF THE SHIPPER OR CONSIGNEE OR ANY OTHER PARTY WHO CLAIMS AN INTEREST IN THE SHIPMENT.

b) THE NATURE OF THE SHIPMENT OR ANY OF ITS CHARACTERISTICS OR INHERENT IN THEM.

c) VIOLATION BY THE SHIPPER OR CONSIGNEE OF ANY TERM OR CONDITION, STATED HEREIN INCLUDING, BUT NOT LIMITED TO, PROPER OR INSUFFICIENT PACKING, SECURING, MARKING OR ADDRESSING, MISLABELLING THE CONTENTS OF ANY SHIPMENT OR FAILURE TO OBSERVE ANY OFFSHORE RULES RELATING TO THE SHIPMENT, NOT ACCEPTABLE FOR TRANSPORTATION, WHETHER SUCH RULES ARE NOW OR HEREAFTER ANNOUNCED BY ARAMEX.

d) Acts of God, acts of war, insurrection, public authority, acts of war or insurrection, or insurrection, or other government officials, strikes or other local, regional or national incidents to a state or where the conditions (temperature or atmospheric charges or conditions) mechanical or other delay off any aircraft used in providing transportation services or any other cause reasonably beyond the control of ARAMEX.

e) Acts of omission off any postal service, warehouse, any other entity, to whom a shipment is delivered by ARAMEX. For transportation, regardless off whether the shipper requested or had knowledge off such third party delivery requirement.

f) Electrical or magnetic injury, erosion, or other such damage to electronic or photographic images or recordings in any form, damage due to insects or vermin.

g) While ARAMEX WILL ENDEAVOR TO EXERCISE ITS BEST EFFORTS TO PROVIDE EXPEDITIOUS DELIVERY IN ACCORDANCE WITH REGULAR DELIVERY SCHEDULE, ARAMEX WILL NOT UNDER ANY CIRCUMSTANCES BE LIABLE FOR DELAY IN PICKUP, TRANSPORTATION OR DELIVERY OFF ANY SHIPMENT, REGARDLESS OFF THE CAUSES OFF SUCH DELAY.

7. MATERIALS NOT ACCEPTABLE FOR TRANSPORT

ARAMEX WILL NOTIFY CUSTOMER FROM TIME TO TIME AS TO CERTAIN CLASSES OFF MATERIALS WHICH ARE NOT ACCEPTED BY ARAMEX. THE CUSTOMER'S RESPONSIBILITY TO ACCURATELY DESCRIBE THE SHIPMENT ON THIS AIRWAYBILL AND TO ENSURE THAT NO MATERIAL IS DELIVERED TO ARAMEX WHICH HAS BEEN DECLARED TO BE UNACCEPTABLE BY ARAMEX.

8. ARAMEX WILL NOT CARRY:

a) Property the carriage off which is prohibited by any legislation or statute or local government off any country, territory, through which the property may be carried.

b) Firearms, bullion, works off art, negotiable instruments in bearer form.

c) Jewelry, precious metals, stamps, precious stones, lead, obscene or pornographic material, hazardous or combustible material.

d) Currency, money orders, traveler's checks, industrial carbon and diamonds.

e) Cables, plants, animals.

f) Antiques, plants, animals.

9. THE EVENT THAT ANY CUSTOMER SHOULD CONSIGN TO ARAMEX ANY SUCH MATERIALS DESCRIBED ABOVE, OR ANY ITEM WHICH THE CUSTOMER HAS UNDervalued FOR CUSTOMER PURPOSES OR MISDESCRIBED WHETHER INTENTIONALLY OR OTHERWISE, THE CUSTOMER SHALL INDEMNIFY AND HOLD ARAMEX HARMLESS FROM ALL CLAIMS, FINES AND EXPENSES ARISING IN CONNECTION THEREWITH. ARAMEX SHALL HAVE THE RIGHT TO ABANDON SUCH PROPERTY AND/OR RELEASE POSSESSION OFF SAID PROPERTY TO ANY AGENT OR EMPLOYEE OFF ANY NATIONAL OR LOCAL GOVERNMENT CLAIMING JURISDICTION OVER SUCH MATERIALS IMMEDIATELY UPON ARAMEX OBTAINING KNOWLEDGE THAT SUCH MATERIALS VIOLATING THESE CONDITIONS HAVE BEEN TURNED OVER TO ARAMEX. SHALL BE FREE TO EXERCISE ANY OFF ITS RIGHTS RESERVED UNDER THIS SECTION WITHOUT INCURRING LIABILITY WHATSOEVER TO THE CUSTOMER.

10. PACKAGING

The packaging off the customer's documents or goods for transportation is the customer's responsibility including the placing off the goods or documents in any container which may be supplied by the customer to ARAMEX. ARAMEX ACCEPTS NO RESPONSIBILITY FOR LOSS OR DAMAGE TO DOCUMENTS OR GOODS CAUSED BY INADEQUATE OR INAPPROPRIATE PACKAGING. THE SOLE RESPONSIBILITY OFF THE CUSTOMER TO ADDRESS ADEQUATELY EACH CONSIGNMENT OFF DOCUMENTS OR GOODS TO BE EFFECTIVE DELIVERY TO THE CUSTOMER SHALL BE THE CUSTOMER'S. THE CUSTOMER'S RESPONSIBILITY RESULTING FROM THE CUSTOMER'S FAILURE TO COMPLY WITH ITS OBLIGATIONS IN THIS RESPECT.

11. NEGLIGENCE

The customer is liable for all losses, damages and expenses arising as a result off its failure to comply with its obligations under this agreement as a result off its negligence.

12. CHARGES

Any rates quoted by ARAMEX for carriage are inclusive off local airport taxes, inclusive off any value added taxes, levies, imposts, deposits or duties incurred in respect off carriage off the customer's goods. Should the customer indicate by endorsement in the space provided on the airbill that the receiver shall be liable for any customs duties, the receiver shall be liable for such customs duties in the event off a default in payment by the receiver. ARAMEX WILL NOT BE LIABLE FOR ANY PENALTIES (IMPOSED OR LOSS OR DAMAGE INCURRED) DUE TO THE CUSTOMER'S DOCUMENTS OR GOODS BEING IMPOUNDED BY CUSTOMS OR SIMILAR AUTHORITIES AND THE CUSTOMER HEREBY INDEMNIFIES ARAMEX AGAINST SUCH PENALTIES OR LOSS.

13. PROPERTY

ARAMEX WILL ONLY CARRY DOCUMENTS OR GOODS WHICH ARE THE PROPERTY OFF THE CUSTOMER AND THE CUSTOMER WARRANTS THAT IT IS AUTHORIZED TO ACCEPT AND IS ACCEPTING THESE CONDITIONS NOT ONLY ON BEHALF OFF ITSELF BUT AS AGENT AND ON BEHALF OFF ALL OTHER PERSONS WHO ARE OR MAY HEREAFTER BE INTERESTED IN THE DOCUMENTS OR CUSTOMER HEREBY UNDERTAKES TO INDEMNIFY ARAMEX AGAINST ANY CLAIMS, DAMAGES AND EXPENSES RESULTING FROM ANY BREACH OFF THIS WARRANTY.

14. CLAIMS

ANY CLAIMS AGAINST ARAMEX MUST BE SUBMITTED IN WRITING TO THE OFFICE OF ARAMEX NEAREST THE LOCATION WHERE THE SHIPMENT WAS ACCEPTED, WITHIN SIXTY (60) DAYS OF THE DATE OF ACCEPTANCE BY ARAMEX.

15. NON-DELIVERY OF SHIPMENT

Notwithstanding the above, in the event off a non-delivery, the shipper shall be liable for all costs and expenses related to the shipment off the carrier's costs incurred in either returning the shipment or warehousing the shipment pending disposition.

16. INSURANCE

a) ARAMEX MAINTAINS CARGO LIABILITY INSURANCE TO THE FULL EXTENT OFF THE LIABILITY OFFERED TO THE SHIPPER.

b) At the request off the shipper and upon payment therefor off the then prevailing rate, ARAMEX WILL ARRANGE INSURANCE COVERAGE ON BEHALF OFF THE SHIPPER IN AN AMOUNT NOT EXCEEDING TEN THOUSAND DOLLARS (US\$10,000.00).

c) The insurance cover shall be governed by all the terms and conditions contained in the policy off insurance issued by insurance carrier. Certificate evidencing such insurance will be made available to the shipper.

d) CONSEQUENTIAL DAMAGES AND LOSS OR DAMAGE RESULTING FROM DELAYS IN TRANSPORTATION ARE NOT COVERED BY ANY SUCH POLICY OF INSURANCE.

17. WARSAW CONVENTION

Where the rules relating to liability established by the Warsaw convention or the Montreal convention apply, carrier's liability is governed by and shall be limited in accordance with such rules. Subject to applicable law, where the Warsaw convention or the Montreal convention do not apply to a loss or damage, liability is governed by these terms and conditions and shall be limited to proven damages up to an amount not exceeding US\$20,000 per shipment.

THIS IS A NON-NEGOTIABLE AIRBILL. ALL SERVICES PROVIDED ARE SUBJECT TO THE TERMS AND CONDITIONS SET FORTH ON THE REVERSE OF SHIPPER'S COPY. BY SIGNING THIS AIRBILL, THE SHIPPER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX'S LIABILITY IS LIMITED TO US\$100.00 IN TENDERING THIS SHIPMENT. SHIPPER AGREES THAT ARAMEX SHALL NOT BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM THE CARRIAGE HEREIN. ARAMEX DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED WITH RESPECT TO THIS SHIPMENT.
