### CONDITIONS OF CARRIAGE

1. IN TENDERING THIS AIRWAYBILL, THE CUSTOMER AGREES TO THESE TERMS AND CONDITIONS OF CARRIAGE AND TRANSIT AND TO HOLD ARAMEX HARMLESS AND TO BE BOUND BY THE CUSTOMER'S OBLIGATIONS UNDER THESE CONDITIONS. ARAMEX INCLUDES ARAMEX AND ITS OPERATING DIVISIONS AND SUBSIDIARIES, ITS AGENTS, AND OTHER RESPECTIVE AGENTS, OFFICERS AND EMPLOYEES.

2. SCOPE OF CONDITIONS  
These conditions apply to all services provided by ARAMEX. SIGNING THIS AIRWAYBILL, THE CUSTOMER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX SHALL NOT BE BOUND BY ANY AGREEMENT WHICH VARIES FROM THESE CONDITIONS. THIS AGREEMENT IS WRITING AND SIGNED BY AN AUTHORIZED OFFICER OF ARAMEX. THE ASSISE OF SUCH WRITING AGREEMENTS THESE CONDITIONS SHALL CONSTITUTE THE ENTIRE AGREEMENT BETWEEN ARAMEX AND EACH OF ITS CUSTOMERS. EMPLOYEE OF ARAMEX SHALL HAVE THE AUTHORITY TO ALTER OR WAIVE THESE TERMS AND CONDITIONS AS STATED HEREIN.

3. ARAMEX'S OBLIGATIONS  
ARAMEX agrees, subject to receiving payment of applicable rates and charges in effect on the date of acceptance by ARAMEX of a shipment to arrange for the transportation of the shipment between the locations agreed upon by ARAMEX and the customer.  
ARAMEX reserves the right to transport the cargo/shipment by any route and procedure and by successive carriers and according to its own handling, storage and transportation methods.

4. SERVICE RESTRICTION  
a) ARAMEX reserves the right to refuse any documents or parcels from any person or company at its own discretion.  
b) ARAMEX reserves the right to abandon carriage of any shipment at any time after acceptance when such shipment could possibly cause damage or delay to other shipments, equipment or personnel or when any such carriage is prohibited by law or is in violation of any of the rules contained herein.  
c) ARAMEX reserves the right to open and inspect any shipment consigned by a customer to ensure that it is capable of carriage to the stated or country of destination within the standard customs procedures and handling methods of ARAMEX. ARAMEX does not warrant that any particular item to be carried is capable of carriage without infringing the law of any country or state through which the item may be carried.

5. LIMITATION OF LIABILITY  
Subject to Section 6 and hereof:  
a) ARAMEX shall be responsible for the cargo/shipment only while it is in ARAMEX custody and control. ARAMEX shall not be liable for loss or damage of a shipment while the shipment is out of ARAMEX custody or control. ARAMEX'S LIABILITY IS IN ANY EVENT LIMITED TO ONE HUNDRED DOLLARS (US\$100) or its equivalent per shipment unless a higher value is declared on the Airway Bill at the time of tender and an additional charge is paid. Losses and damages determined by ARAMEX for each one hundred Dollars (US\$100) or fraction thereof which the insured value designated by the customer on the Airway Bill exceeds One Hundred Dollars (US\$100) per shipment.  
b) Notwithstanding the foregoing, the customer shall be responsible for the cargo/shipment if the value of the cargo/shipment exceeds One Hundred Dollars (US\$100) on the Airway Bill. ARAMEX'S liability shall in any event be limited to the lower of the insured value or the amount of any loss or damage actually sustained by the customer.  
c) The actual value of a shipment shall be ascertained by reference to its replacement value or reconstruction value at the time and place of shipment. However, it is, without reference to its commercial utility to the customer or to other items of consequential loss.  
d) NOTWITHSTANDING ANY OF THE FOREGOING, THE MAXIMUM INSURED VALUE ON ANY SHIPMENT ACCEPTED BY ARAMEX IS TEN THOUSAND DOLLARS (US\$10,000.00) AND IN NO EVENT SHALL THE LIABILITY OF ARAMEX EXCEED THAT AMOUNT.

6. CONSEQUENTIAL DAMAGES EXCLUDED  
ARAMEX SHALL NOT BE LIABLE IN ANY EVENT, FOR ANY CONSEQUENTIAL OR SPECIAL OR INCIDENTAL DAMAGE OR OTHER INDIRECT LOSS HOWEVER ARISING, WHETHER OR NOT ARAMEX HAD KNOWLEDGE THAT SUCH DAMAGE MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO LOSS OF INCOME, PROFITS, INTEREST, UTILITY OR LOSS OF MARKET.

7. LIABILITY NOT ASSUMED  
a) ARAMEX shall be not liable for any loss/damage, delay, misdelivery or nondelivery not caused by its own negligence. For any loss/damage, delay, misdelivery or nondelivery caused by:  
i) the act/omission of or omission of the shipper or consignee or any other party who claims an interest in the shipment.  
ii) the nature of the shipment or any defect/characteristic or inherent vice thereof.  
iii) violation by the shipper or consignee of any terms or condition stated herein including, but not limited to, improper or insufficient packing, securing, marking or addressing, misdescribing the contents of any shipment or failure to observe any of the rules relating to the shipment not acceptable for transportation whether such rules are now or hereafter promulgated by ARAMEX.  
iv) Acts of God, piracy, terrorism, insurrection, hostilities, war, or any other cause beyond the control of ARAMEX.  
v) strikes or other local disturbances and no claims to a state of emergency, conditions of temperature, atmospheric changes or conditions mechanical or other delay of any aircraft, vessel or conveyance or any other cause beyond the control of ARAMEX.  
vi) acts or omissions of any postal service/authorities or any other entity to whom a shipment is tendered by ARAMEX for transportation and/or whether the shipper furnished or had knowledge of such third party delivery requirements.  
vii) Electrical, magnetic injury, explosion, or other loss/damage to electronic or photographic images or recordings, in any form/damage due to insects or vermin.  
b) While ARAMEX will endeavor to exercise its best efforts to provide expeditious delivery, in accordance with regular delivery schedules, ARAMEX will not under any circumstances be liable for delay in pickup/transportation or delivery of any shipment regardless of the causes of such delay.

8. PACKAGING  
The packaging of the cargo/documents or goods for transportation is the customer's responsibility including the placing of the goods or documents in any container which may be supplied by the customer. If ARAMEX accepts responsibility for loss or damage to documents or goods caused by inadequate or inappropriate packaging, the sole responsibility of the customer to address adequately each consignment of documents or goods to enable effective delivery to the customer shall not be liable for delay in forwarding or delivery resulting from the customer's failure to comply with its obligations in this respect.

9. NEGLIGENCE  
The customer is liable for all losses/damages and expenses arising as a result of its failure to comply with its obligations under this agreement as a result of its negligence.

10. CHARGES  
Any rates quoted by ARAMEX for carriage are inclusive of local airport taxes exclusive of any value added taxes, levies, imposts, deposits or outlays incurred in respect of carriage of the customer's goods. Should the customer indicate by endorsement in the space provided on the airbill that the receiver shall be liable for any customs/duties, the receiver shall be liable for such customs duty in the event of a default in payment by the customer. ARAMEX will not be liable for any penalties imposed or loss or damage incurred due to the customs/documents or goods being impounded by customs or similar authorities and the customer hereby indemnifies ARAMEX against such penalty or loss.

11. PROPERTY  
ARAMEX will only carry documents of goods which are the property of the customer and the customer warrants that it is authorized to accept and is accepting these conditions not only on behalf of itself but as agent and on behalf of all other persons who are or may hereafter be interested in the documents/goods. The customer hereby undertakes to indemnify ARAMEX against any damages costs and expenses resulting from any breach of this warranty.

12. CLAIMS  
ANY CLAIMS AGAINST ARAMEX MUST BE SUBMITTED IN WRITING TO THE OFFICE OF ARAMEX NEAREST THE LOCATION WHERE THE SHIPMENT WAS ACCEPTED, WITHIN SIXTY (60 DAYS) OF THE DATE OF ACCEPTANCE BY ARAMEX.

13. NON DELIVERY OF SHIPMENT  
Notwithstanding the above, the shipper shall be liable for all costs and expenses related to the shipment of the cargo/shipment or costs incurred in either returning the shipment or warehousing the shipment pending disposition.

14. INSURANCE  
a) ARAMEX maintains cargo liability insurance to the full extent of the liability offered to the shipper.  
b) At the request of the shipper and upon payment therefor at the then prevailing rates, ARAMEX will arrange insurance coverage on behalf of the shipper in an amount not exceeding Ten Thousand Dollars (US\$10,000).  
c) The insurance cover shall be governed by all the terms and conditions contained in the policy of insurance issued by insurance carrier/insurer. Evidence of such insurance will be made available to the shipper.  
d) CONSEQUENTIAL DAMAGES AND LOSS OR DAMAGE RESULTING FROM DELAYS IN TRANSPORTATION ARE NOT COVERED BY ANY SUCH POLICY OF INSURANCE.

15. WAIVER OF CONVENTION  
Where the carrier's liability established by the Warsaw Convention or the Montreal Convention is applicable, the carrier's liability is governed by and shall be limited in accordance with such rules. Subject to applicable law/where the Warsaw Convention or the Montreal Convention do not apply, no loss or damage is governed by these rules and conditions and shall be limited to proven damages up to an amount not exceeding US\$500 per shipment.  
THIS IS A NON-NEGOTIABLE AIRWAYBILL. SERVICES PROVIDED ARE SUBJECT TO THE TERMS AND CONDITIONS SET FORTH ON THE REVERSE OF SHIPPER'S COPY. BY SIGNING THIS AIRWAYBILL, THE SHIPPER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX'S LIABILITY IS LIMITED TO US\$100 IN TENDERING THIS SHIPMENT. SHIPPER AGREES THAT ARAMEX SHALL NOT BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM THE CARRIAGE HEREOF. ARAMEX DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED WITH RESPECT TO THIS SHIPMENT.
