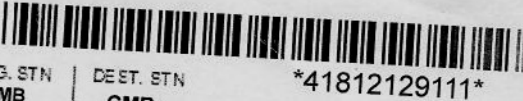

CONDITIONS OF CARRIAGE

In forwarding the shipment the customer agrees to these terms and conditions of carriage and that this is the entire contract and all services and other conditions of carriage shall be those conditions of carriage of ARAMEX, including Aramex and its agents, subsidiaries and employees.

1. SCOPE OF CONDITIONS
These conditions shall govern all services provided by ARAMEX'S DOMESTIC AND INTERNATIONAL CUSTOMER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY THEM. ARAMEX SHALL NOT BE BOUND BY ANY AGREEMENT WHICH CONTRARIES THESE CONDITIONS AND CONDITIONS OF CARRIAGE.

2. ARAMEX'S OBLIGATIONS
ARAMEX agrees to deliver the goods in accordance with the terms and conditions of carriage and to provide the services and facilities as set out in the conditions of carriage.

3. SERVICE RESTRICTIONS
ARAMEX reserves the right to refuse any documents or parcels from any person or company at its own discretion and to refuse to accept any goods for shipment at any time other than those specified in the conditions of carriage.

4. LIMITATION OF LIABILITY
ARAMEX'S LIABILITY FOR LOSS OF OR DAMAGE TO GOODS IS LIMITED TO THE AMOUNT OF THE INVOICED VALUE OF THE GOODS AT THE TIME OF SHIPMENT.

5. CONFIDENTIAL DAMAGES EXCLUDED
ARAMEX SHALL NOT BE LIABLE IN ANY EVENT, FOR ANY CONFIDENTIAL OR SPECIAL OR INCIDENTAL DAMAGES OR OTHER INDIRECT LOSS HOWEVER ARISING, WHETHER OR NOT ARAMEX HAS KNOWLEDGE THAT SUCH DAMAGES MIGHT BE INCURRED, INCLUDING, BUT NOT LIMITED TO LOSS OF PROFITS, INTEREST, UTILITY OR LOSS OF MARKET.

6. LIABILITY NOT ASSURED
ARAMEX shall not be liable for any loss or damage to goods caused by fire, theft, pilferage, robbery, hijacking, piracy, terrorism, sabotage, war, civil unrest, riot, strike, lock-out, general or partial strike, or any other cause beyond the control of ARAMEX.

7. FORCE MAJEURE
If the carrier or its agent or its sub-contractor is prevented from performing its obligations under this agreement by an event beyond its control, it shall be relieved of its obligations under this agreement for the period of such prevention.

8. INSURANCE
The customer is responsible for insuring the goods against loss or damage during transit.

9. CONFIDENTIAL DAMAGES AND LOSS OR DAMAGE RESULTING FROM DELAYS IN TRANSPORTATION ARE NOT COVERED BY ANY SUCH POLICY OF INSURANCE.

10. WAREHOUSE CONVENTION
Where the rules relating to liability established by the Warsaw Convention or the Montreal Convention apply, the liability is governed by and shall be limited to the maximum amount of compensation provided in such Convention.
