 Notwithstanding the information on the consignment slip, the carrier shall be liable for all costs and expenses related to the shipment of the goods or costs incurred in either returning the shipment or warehousing the shipment pending disposition.

14. INSURANCE:
 ARAMEX maintains cargo liability insurance to the full extent of the liability offered to the shipper.

15. LOSS OF RECEIPT:
 If the receipt of the shipper and upon presentation at the time provided ARAMEX will arrange insurance coverage on behalf of the shipper in an amount not exceeding Ten Thousand Dollars (US\$10,000).

16. THE INSURANCE COVER SHALL BE GOVERNED BY ALL THE TERMS AND CONDITIONS CONTAINED IN THE POLICY OF INSURANCE ISSUED BY INSURANCE CARRIER/COMPANY EVIDENCING SUCH INSURANCE WILL BE MADE AVAILABLE TO THE SHIPPER.

17. CONSEQUENTIAL DAMAGES AND LOSSES OR DAMAGE RESULTING FROM DELAYS IN TRANSPORTATION ARE NOT COVERED BY ANY SUCH POLICY OF INSURANCE.

18. WARSAW CONVENTION:
 Where the rules relating to liability established by the Warsaw convention or the convention apply, carrier's liability is governed by and shall be limited in accordance with such rules. Subject to applicable law where the Warsaw convention or the convention do not apply, liability is governed by these terms and conditions and shall be limited to proven damages up to an amount not exceeding US\$100,000 per shipment.

19. THIS IS A NON-NEGOTIABLE AIRBILL. ALL SERVICES PROVIDED ARE SUBJECT TO THE TERMS AND CONDITIONS SET FORTH ON THE REVERSE OF SHIPPER'S COPY. BY SIGNING THIS AIRBILL, THE SHIPPER ACKNOWLEDGES THAT HE/SHE HAS READ THESE CONDITIONS AND AGREES TO BE BOUND BY EACH OF THEM. ARAMEX'S LIABILITY IS LIMITED TO US\$100,000 IN TENDERING THIS SHIPMENT SHIPPER AGREES THAT ARAMEX SHALL NOT BE LIABLE FOR SPECIAL INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM THE CARRIAGE HEREOF. ARAMEX DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED WITH RESPECT TO THIS SHIPMENT.
